

# The Acting Public Protector, Advocate Kholeka Gcaleka visits UNIVEN

On Tuesday, 16 March 2021, the Acting Public Protector, Advocate Kholeka Gcaleka visited the University of Venda (UNIVEN) to engage with various stakeholders about a strategy that her office is working on to address some of the challenges at higher education institutions. Participants in the meeting were the University management, student leadership, the National Student Financial Aid Scheme (NSFAS) and the South African Human Rights Commission. This meeting took place at UNIVEN Research Conference Centre.

Advocate Gcaleka highlighted that, without education, we will never preserve the future of this country. "We need to be visionaries as the leaders of today. We need to avoid a situation where every year, the children of this country are being chased by the police trying to fight for access to education."

She advised UNIVEN SRC to speak about all their challenges, so that they could be resolved harmoniously.



Advocate Gcaleka said in 2020, the Public Protector's Office received NSFAS related complaints, which include inadequate allowances for study material and nonpayment of living allowances.



In his response, the Vice-Chancellor and Principal, Dr Bernard Nthambeleni highlighted several challenges facing the University.

Among other matters, Dr Nthambeleni presented analysis of the University's status; background and context; how to position UNIVEN for impact; UNIVEN revenue sources; UNIVEN Student Funding issues; Challenges with NSFAS and UNIVEN management's actions to resolve NSFAS and other financial issues.

He said, government grants remain the key source of revenue for UNIVEN. "Over 11 879 which is 78% of our students are funded by NSFAS and other government departments. About 3 459 students are in the 'missing middle category'. These are students whose family household' income exceeds the maximum amount required to qualify for NSFAS but are still unable to fund university studies." Dr Nthambeleni further highlighted that, these missing middle students currently owe the University about R92 million rand and the debt is increasing every year. He said that the UNIVEN overall historical student debt balances at the end of 31 December 2020 was R441 million.

When talking about the issue of gadgets that are meant to assist students with online learning, Dr Nthambeleni said that the University started allocating tablets to all registered students' way back in 2015. However, the University no longer provide tablets to students, "we are now giving them laptops".


## The Acting Public Protector, Advocate Kholeka Gcaleka visits UNIVEN continued...



UNIVEN SRC President, Mr Gift Chauke highlighted the issues that students come across every year. He explained that, UNIVEN students are struggling a lot financially because it seems like NSFAS does not take them serious like students from other universities. "All we need is fair treatment from NSFAS". Other issues that Mr Chauke has highlighted were challenges of students who stay in villages where there is limited internet access or no network coverage at all. He said online learning is not possible for those students.

He further stressed the issue of funding for postgraduate students and student safety on and off campus. "On campus we do not have challenges as such, however we experience problems with students who get robbed or raped at off campus non-accredited residences. We also need to assist students who are staying at these residences with funds to access accredited residences."

When talking about the issue of national shutdown at tertiary institutions, Mr Chauke said that, UNIVEN situation is different from other universities, hence we allowed our students to finish the 2020 academic year before they could talk about the national shutdown. "It is not like we did not want to participate in the total shutdown. These challenges also affect us, but we also need to be in the same academic year with students from other universities," he said.





In her response, Senior Legal Officer at Human Rights Commission Limpopo Provincial Office, Dr Eileen Carter said students have the rights to access education and that seems to be a challenge in South Africa because the Human Rights Commission receives a lot of complaints about students who couldn't be registered due to their historical debt owed to institutions. She said there should be a funding mechanism that will make sure that all deserving and qualifying students are catered for to avoid financial exclusions at tertiary institutions.



In his opening and welcoming address, the University Registrar, Advocate Edward Lambani cited that, UNIVEN had already anticipated that this visit would yield positive results that will benefit all stakeholders involved. "Even though we feel like this could have been done earlier but we really appreciate the engagement of all stakeholders under one roof.

In her response, NSFAS COO, Ms Nthuseng Mphahlele said in the past three years, NSFAS has experienced a very high expenditure growth due to the demand of prospective students who need financial support for their studies. She said NSFAS make sure that all students are appropriately funded. NSFAS also need to be sure about where such students are registered and that takes time, which leads to delayed payments.

"NSFAS pays an institution (a University) to administer finances for all students that are funded. However, before the funds could be directed to an institution, we first make sure that institutions have proper administration of these funds." She said it is only at TVET Colleges where NSFAS pays funds directly to students and the tuition fees to the TVET College

## UNIVEN and Bester Technology put heads together to bridge digital divide for local communities

On Monday, 29 March 2021, the University of Venda (UNIVEN) met with a delegation from Bester Technology to discuss matters of bringing internet connectivity to communities of Vhembe District Municipality and, ultimately, UNIVEN students, including those residing at off campus accredited residences. This meeting took place at UNIVEN Council Chambers.



When welcoming the delegation from Bester Technology, Vice-Chancellor and Principal, Dr Bernard Nthambeleni clarified that UNIVEN is not a rural University but a University based in a rural area. "We want to become a role player that makes impact in our community, where we are located hence one of our institutional values is that we have accepted our social responsibility and community engagement in serving and contributing to the intellectual, social and economic well-being of our communities." He said UNIVEN is ready to play an active role in the economy of the area where it is located. Dr Nthambeleni said that the UNIVEN Innovative Growth Company (UIGC) will assist the University in playing a big role to boost the local area economically. UIGC has an important role of linking the University with the communities and what is happening around those communities.

"Times have changed drastically since December 2019. We found ourselves having to change the way we teach our students due to COVID-19 pandemic. We want to make sure that our University thrive towards achieving its goal even amidst this pandemic. We always strive to accommodate our students at secured residences with Wi-Fi connectivity."

He concluded his welcome message by mentioning that for the University to achieve its goal, there is a need to strengthen partnerships. The Vice-Chancellor its showed that partnerships should be key in achieving our core business of teaching and learning. As a University, we must come up with projects that benefit students and communities around us - in other words we want to improve the lives of people by providing solutions to the problems, he added. Dr Nthambeleni said he is looking forward that this partnership will be a game changer in addressing the problems we are faced with. "We are aware that to achieve what we want to achieve, we need to partner with companies and organisations that will assist the University to fulfill its role. We need to give and not expect anything in return.



Chief Executive Officer of Bester Technology, Helen Gao said that, since 2019, Bester has established Technology several companies worldwide. We now have seven (7) design subsidiary companies in China. "We are trying to stretch our performance in the technology industry. We want to become infrastructure owner in South Africa and we want to be the key ICT service provider in this area." She continued to highlight that, one of their goals as Bester Technology is to own the network in rural areas and provide surrounding communities with internet connectivity



UIGC CEO, Dr John Mudau said the University has started working with the surrounding communities regarding improvements in their area, however, the point of community interaction is municipalities within those communities. Dr Mudau concluded his talk by mentioning that they have started to liaise with Thulamela and Collins Chabane Local Municipalities. "The news of Bester Technology coming on board is exciting to us because they came at the right time."

# Stress has a negative impact on individual's productivity



On Thursday, 25 March 2021, the University of Venda (UNIVEN)'s Employee Health and Wellness Section of Human Resources Directorate, held a Virtual Stress Management Workshop to educate and equip staff members with stress management skills. This workshop was organised for UNIVEN employees as a provision to handle stress. The workshop which was facilitated by Ms Andiswa Lefakane from Careways took place on Microsoft Teams.

Ms Lefakane highlighted that stress has a negative impact on individual's productivity especially for those who are experiencing personal, family, and workrelated challenges. She said that the possible results of stress are depression, absenteeism, low morale, and low productivity. It can also cause defensiveness, lack of motivation, difficulty concentrating, accidents and interpersonal conflict.

Five Higher Education Institutions (HEI) offering Forestry education in South Africa have joined three European universities in a project entitled Forest21. This funded Forest21 Project aims to advance the quality of education in the field of Forestry Entrepreneurship through problem-based learning.

The €1 Million project, funded by the Erasmus+ programme of the European Union entitled '21st Century Climate-Smart Forestry Education for Livelihood and Sustainability in South Africa', is a collaborative project that will strengthen the capacity of forestry entrepreneurship in South African higher education.

Through curricula reformation in Forestry Education, students will be equipped with entrepreneurial skills and a deeper understanding of climate-smart approach to Forestry. The University of Venda (UNIVEN) is among the five South African Higher Education Institutions that are participating in the FOREST21 project.

Forestry discipline is strategically positioned to address unemployment, as well as to mitigate global climate change. Young Forestry Entrepreneurs hold enormous potential to address these challenges through the development of products and processing of forestry resources. Through FOREST21 project, Forestry Education will be reformed to meet the needs in the industry, and climate-smart Forestry will be emphasised.

Entrepreneurship education and problembased learning methods will be developed together with the teaching staff and managerial staff. Students will learn practical skills through solving real-life challenges in Forestry industry. "FOREST21 provides a unique opportunity for the forestry sector to work closely with all forestry HEIs in South Africa and partner with HEIs in Finland and Norway", says Norman Dlamini, Director of Business Development at Forestry South Africa. "The project supports the key efforts of the country in dealing with the triple ills of unemployment, poverty and inequality. It also improves the country's efforts towards the mitigation of and adaptation to climate change. The emphasis on forestry entrepreneurship and climate change is exactly what the country needs right now."

Other South African participating universities are Nelson Mandela University, Stellenbosch University, Fort Cox Agriculture and Forestry Institute and Tshwane University of Technology. Dr Eija Laitinen who is the Project manager and Principal Research Scientist at the Bio Economy Research Unit at Häme University of Applied Sciences in Finland said that the forestry industry in South Africa is strongly committed to this project. "In addition to curricula reformations, collaboration between the industry and education will be strengthened."

FOREST21 is a collaborative project funded by the Erasmus+ programme of the European Union with a budget of approximately one million euros for a period of three years (2021–2024). UNIVEN's Prof Peter Adesoye who is the Head of Forestry Department highlighted that FOREST21 project is timely because UNIVEN's Forestry Department is in a transition phase from BSc Agriculture (Forestry) into BSc Forestry.





## Community Engagement Directorate organises a successful virtual Social Entrepreneurship Workshop



On Wednesday, 24 March 2021, the Community Engagement Directorate held a virtual Social Entrepreneurship Workshop under the theme, 'Introduction to Social Enterprise: Rethinking Business'. The major purpose of the workshop was to expose students and staff to the concept of social entrepreneurship and show how social entrepreneurs are transforming society to deliver social impact in their home communities and abroad. Dr Danylle Kunkel, Associate Professor at Radford University College of Business and Economics in Virginia, USA facilitated the workshop via Microsoft teams. More than 80 people drawn from the UNIVEN campus and notably, the Limpopo Chamber of Commerce and Industry participated in this workshop.

Prof Kunkel clarified that Social entrepreneurship focused on creation of social impact through developing and implementing a sustainable business model which draws on innovative solutions that benefit the disadvantaged and, ultimately, society at large. She highlighted the leveraging innovations results towards the creation of positive social impact within grassroots communities. "Social enterprises are distinctive because their purpose is central to what they do," she said. Prof Kunkel encouraged emerging entrepreneurs to never give up if they want to succeed.

The Deputy Vice-Chancellor Corporate Services, Dr Robert Martin welcomed attendees to the workshop and encouraged them to contribute, explore and learn as much as they could. He argued that this was important because social entrepreneurship will play a major role in the implementation of the University of Venda's 2021-2025 Strategic Plan.

In his vote of thanks message, Director Institute for Rural Development, Prof Joseph Francis said unique platforms such as the workshop are encouraging because they taught students, staff, and external stakeholders such as provincial entrepreneurs to unlock their potential and assets to help them flourish in the business world. He concluded his remarks by mentioning that this workshop was relevant especially with respect to the operationalisation of the University's Strategic Thrust 2. The workshop was facilitated by Prof Mashudu Mashige, a Research Professor in the School of Human and Social Sciences of the University of Venda.

Overall, the workshop revealed that social enterprise was a rapidly developing field and that through its application, entrepreneurs and social innovators use business methods to help solve economic, social, and environmental challenges. These are matters that, otherwise, are ignored by commercial businesses and often difficult to financially sustain in the nonprofit sector.
