# **1st Call for Abstracts**

The University of Venda understands internationalisation at the institutional level as 'the process of integrating international and intercultural dimensions into the teaching, research, community engagement and service functions of an institution of higher learning.' Internationalisation of the university's core business is a core pillar of UNIVEN's transformation process to become and remain a locally relevant, internationally competitive university.

The University of Venda, through the Directorate of International Relations and Partnerships, hosts the 2024 Internationalisation Week from the 9th to the 13th of September 2024 at the University of Venda, Limpopo Province, South Africa.

The Directorate of International Relations and Partnerships organises Internationalisation Week annually. Still, the 2024 annual event is organised to provide a platform for academics, researchers, Master and Doctoral students to share their research findings with local and global experts.
